Súkromná spojená škola Cambridge International School, with its registered set at Úprkova 3, 811 04 Bratislava, Slovakia, ID no: 42261121 (hereinafter the „**Controller** “) in connection with the processing of personal data of students interested in attending the Collector as a school and his/her legal representatives (hereinafter the „**Data Subjects**“ or individually as „**Data Subject**“), hereby according to Section 19 of Act No. 18/2018 Coll. on personal data protection and on amendment and supplementing of some acts, as amended (hereinafter referred to as “**Personal Data Protection Act**”) provides the Data Subject with following information:

- (i) The controller of the information system is the private joint school Cambridge International School, with its registered set at Úprkova 3, 811 04 Bratislava, Slovakia, ID no: 42261121. The Data Subject is entitled to contact the Controller at the address of registered seat or at email address data@cambridgeschool.eu;
- (ii) The Controller processes the personal data of the Data Subject for the purpose of processing and assessment of the Admission Enquiry Form and realisation of the selection procedure;
- (iii) The legal basis for the processing of the personal data of the Data Subject is the necessity to process this data in order to take steps at the request of the Data Subject prior to entering into a contract with respect to the providing the education;
- (iv) Except for the cases expressly listed in this document or in the generally binding legal regulations the Controller will not provide the personal data of Data Subject to the recipients. The personal data of Data Subject can be disclosed to accountants, auditors, tax, legal or other advisors and to subjects which are entitled to receive such data according to law. To the extent strictly necessary in order to fulfil the purpose of processing of the personal data, the Controller is authorized to disclose the personal data to another subject e.g. subcontractors, couriers etc. The personal data can be also provided to the companies (enterprises) of the group where the Controller and its founder belong (mainly parent and subsidiary companies). The personal data will not be transferred to a third country (country, which is not a member of European Union or party of the Agreement on the European Economic Area) or international organisation;
- (v) The Controller will maintain the personal data of Data Subject for the period of 3 years from the end of the school year during which the student visits the Controller as a school the last time;
- (vi) The Data Subject has the right to obtain from the Controller confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to the personal data according to Section 21 of Personal Data Protection Act;
- (vii) The Data Subject is authorized to request from the Controller (without undue delay) the rectification of inaccurate personal data concerning him or her. Taking into account the purposes of the processing, the Data Subject has the right to have incomplete personal data completed;
- (viii) The Data Subject has the right to have the personal data concerning Data Subject deleted under the conditions according to Section 23 of Personal Data Protection Act;
- (ix) The Data Subject has the right for limitation of personal data processing under the conditions according to Section 24 of Personal Data Protection Act;
- (x) The Data Subject has the right to receive the personal data concerning him/her, which she/he has provided to the Controller, in a structured, commonly used and machine-readable format and has the right to transmit those data to another controller under conditions according to Section 26 of Personal Data Protection Act, if it is technically possible;
- (xi) The Data Subject has the right to object processing of the personal data in cases and under the conditions according to Section 27 of Personal Data Protection Act;
- (xii) The Data Subject has the right to file an application initiating the proceedings on personal data protection in front of data protection supervisory authority under the conditions according to Personal Data Protection Act;
- (xiii) Processing of personal data of the Data Subject is an inevitable prerequisite in order to process and assess the Admission Enquiry Form and to realise the selection procedure.
